QUESTIONS RECEIVED IN THE DIVISION OF PURCHASES & SUPPLIES For Brake Parts, Bulbs, Breakers, Sprays, & Filters – (3) Years BID# 22000040 (REBID)

- 1. I am looking at page 45 on ITB-B22000040 and have a few questions:
 - 1) You have listed T3 as a part number. This is not a complete part number. Do you have a more detailed part number so I can properly identify?

T3 product information – ¼" wedge base, 12V, 5W, clear, miniature automotive bub like the one shown here:

2) The last 2 items listed on page 45 are Cole Hersee numbers. Per Cole Hersee, 30145-40 is obsolete with no replacement and CB3-SM-100 is not a valid part number. How should I handle?

The 30145-40BX replacement can be quoted instead; vendors may quote an identical part from a different manufacturer as long as the part number and manufacturer are shown on the bid, i.e., this one found with a Google search using the part number provided with the bid:

- 2. Bid B22000040 notes sprays and filters as part of the quote. They are not on this bid. Will they be on a future bid?
 - Sprays and filters are not individually called out for price quotes on the bid, but are simply indicative of other miscellaneous items that the Central Garage may need to purchase throughout the term of the contract. It is unlikely that they will be individually called out on future bids.
- 3. A list of VIN's was sent out to help look up parts for Bid 22000040. On four vehicles multiple VIN's were provided. Should we be quoting, for example 2015-2018 Equinox twice, or can you narrow the quote to one VIN?
 - The multiple VIN's provided are representative of the range of vehicle model years owned or leased by the City of Flint. Vendors are welcome to quote the lowest priced part necessary for any given model year they choose as many are interchangeable between model years and body styles.
- 4. There was no bid sheet for batteries or cars and trucks. Will that be on an upcoming bid?
 - Automotive and truck batteries are not part of this bid. They will be bid separately at another time.



5. I cannot bid on any of these vehicles because they are all missing key information. Motor size, 2 or 4 wd. Vehicles these days are so hard to get correct parts unless you have ALL the information. At my store I sell you parts right the first time, that's why I've been there for 33 years. So if we can get more info? Maybe complete VIN for all vehicles we can sell you parts right the first time at a great price like we use to do in the past before Brown and Sons beat our bid by 10.00 dollars which I thought was very strange?? Look forward to hearing from you soon. Have a great Memorial Day weekend!
