



The City of Flint previously entered into a contract with DTS Contract, Inc., in the amount of \$179,820.00 in order to complete phase two rehabilitation of McKinley Community Center. This work was delayed significantly due to the COVID-19 Pandemic.

The original bid was submitted prior to the COVID-19 Pandemic, and since then the costs of materials and labor have significantly increased, requiring additional funding in the amount of \$90,618.00. Resolution #220056 was passed on 02/14/22 and increased the total contract amount to \$270,438.00.

Once work began in earnest at McKinley, additional items were identified that needed to be repaired or replaced in order to bring the building fully up to code and make the building ADA compliant. This resolution will allocate an additional amount of \$131,768.13 and will allow for the final completion of renovations at McKinley Community Center.

FINANCIAL IMPLICATIONS: Phase 2 rehabilitation directly builds on CDBG funding that has already been spent on phase 1 rehabilitation of the building. If this work doesn't get completed, then the City has to repay the amount already invested/committed to the project (\$270,438.00).



Special Overtime Assignment

This Memorandum of Understanding ("MOU"), made on July ____, 2022, is between the City of Fliat ("City") and the Police Officers Labor Council - Fliat Police Department Lieutenants and Captains ("Union").

RECITALS

WHEREAS, the City and Union are parties to a Collective Bargaining Agreement ("CBA") that was effective through June 30, 2021; and

WHEREAS, the parties are currently in negotiations for a successor Collective Bargaining Agreement; and

WHEREAS, the parties wish to maintain status quo terms and conditions of employment during negotiations for the successor Collective Bargaining Agreement ("CBA"); and

WHEREAS, the City and Union wish to enable the offering of Special Overtime Assignments during negotiations for a successor CBA; and

WHEREAS, the parties commit their understandings in this regard to writing here;

NOW, THEREFORE, the parties agree as follows:

- 1. The Chief of Police, or designee, may offer a Special Overtime Assignment (SOA). SOAs may include assignments related to high drug-trafficking locations, Halloween Eve, elections, violent crime hotspots, human trafficking assignments, or other specific law enforcement concerns as determined by the Chief of Police.
- 2. During the term of this MOU, and subject to the other provisions in this MOU, an Employee will be paid at one and one-half (1½) times the Employee's regular hourly rate for all hours worked under the following conditions:
 - a. The Chief of Police or designee offers a SOA.
 - b. The Employee volunteers to work, and does work, an SOA during a shift that the Employee was not scheduled to work.
 - SOA opportunities are governed by Article 16, Section 4 Scheduled Overtime.

- 4. Overtime hours worked pursuant to this MOU will be charged on the master overtime equalization chart in the same manner as any other overtime hours worked pursuant to Article 16 Overtime and Overtime Pay.

This Memorandum of Understanding ("MOU") is entered into on August _____, 2022, by and between The City of Flint ("City") and the Police Officers Labor Council – Flint Police Department Sergeants ("Union").

RECITALS

WHEREAS, the City and Union entered into a Collective Bargaining Agreement (CBA) in 2019, which expired on June 30, 2020 ("2019 Sergeants' CBA");

WHEREAS, on July 25, 2022, the parties ratified a successor CBA ("2022 Sergeants' CBA");

WHEREAS, under the 2019-2022 CBA between the City and the Flint Police Officers' Association (FPOA), patrol officers may, based on seniority, accumulate up to a maximum of three hundred seventy-eight (378) or four hundred fifty (450) hours of Paid Time Off ("PTO");

WHEREAS, pursuant to the 2019 Sergeants' CBA, Sergeants could only accumulate up to a maximum of three hundred (300) hours of PTO;

WHEREAS, the 2022 Sergeants' CBA increased the maximum accumulation to four hundred fifty (450) hours for Sergeants;

WHEREAS, some persons who recently promoted from Patrol Officer to Sergeant had accumulated PTO in excess of the maximum permitted under the 2019 Sergeant CBA; and

WHEREAS, the parties wish to credit certain PTO hours to the banks of Sergeants that were lost due to accumulation cap in the 2019 Sergeants' CBA;

NOW, THEREFORE, the parties agree as follows:

 - b. The Employee volunteers to work, and does work, an SOA during a shift that the Employee was not scheduled to work.
- 3. SOA opportunities are governed by Article 31 Equalization of Scheduled Overtime.

- 4. Overtime hours worked pursuant to this MOU will be charged on the master overtime equalization chart in the same manner as any other overtime hours worked pursuant to Article 18 Overtime and Overtime Pay.
