PUBLIC HEARING:

ZBA 22-10: Twin Peaks 28 Inc. requests a use variance to allow operation of a members only club in the D-2 district at 2407 Lewis St. Flint, MI 48506 (PID # 41-06-429-035).

Bill Vandercook read the staff report.

The applicant, Kevin Wilson, spoke on the application to request a variance. Mr. Wilson spoke about the properties he owns and his efforts to fix them up. Mr. Wilson said this location has

always been a bar and should continue as a members only club. Mark Ross, attorney for Mr. Wilson, clarified points made by Mr. Wilson.

Jim Peterson, Thang Duc Thach, Jerry Gains, James Kloska, Rene Peterson, and Jean Kloska spoke in opposition to the variance request. The speakers noted concerns of loud music playing all night well into the early morning, violence, littering of trash and needles, gasoline being poured onto the ground to control rats, and lack of emergency vehicle access due to cars parking triple wide on nearby streets.

Mr. Wilson responded to the concerns raised stating the previous tenant is no longer at this location and that he will be taking over operations. Mr. Wilson said the new hours would be from 12:00 p.m. to 2:00 a.m. Mr. Wilson continued by saying he has fixed up his properties and has removed large rats from the area and would add a dumpster area and fencing.

COMMISSION DISCUSSION

Commissioner McCaskill made a motion to deny ZBA 22-10 based on Standard 1, "The property cannot be put to a reasonable use for the purposes permitted in the zone." Staff findings in opposition states "Granting the variance would allow a prohibited use in the D-2 district near existing single-family dwellings changing the character of the D-2 area.

Commissioner Yelle supported the motion.

Chairman Telliga called for a roll call vote.
