This addendum has been published to clarify the following.

Question 1. Is the City of Flint able to provide the bidders the frame size, application, and horsepower of each of the motors included in this RFQ? It is difficult to quote, if not impossible, without at least these three items for each asset included within the RFQ. Bidders would need this information ASAP in order to get accurate bids completed in time to be turned in on or before the 8th of June.

Q1 Response: The Horsepower is already noted in the bid chart. Please see the items in BOLD. The Frame Sizes and Applications to the best of our knowledge have been added.

Question 2. If the frame size, application, and horsepower information isn't provided to bidders in a timeframe conducive to getting the bid complete by the 8th, would the possibility of an extension be granted so that bidders would have enough time to submit accurate pricing?

Q2 Response: The information has been submitted above.

Question 3. If a delivery timeframe that is spelled out in the bid documents is deemed unachievable / unrealistic based on the Frame / Application / Horsepower information given, what would be the impact (if any) on the bidding contractor's bid if the existing delivery expectation within the RFQ documents is modified to what is achievable and more realistic?

Q3 Response: The bid should be submitted with the understanding that the delivery requirements will be met by the contractor. The City understands that there may be external considerations outside of the contractor (such as supply chain delays) that may affect delivery. If a delivery timeframe can not be met, a detailed, written explanation shall be given by the contractor with anticipated associated costs.
