Property, as described in Act 381, including consideration of the criteria of "blighted" as defined in Act 381; ii. The Plan meets the requirements set forth in section 13 of Act 381, iii. The proposed method of financing the costs of eligible activities is feasible and the Authority has the ability to arrange the financing, iv. The costs of eligible activities proposed are reasonable and necessary to carry out the purposes of Act 381. v. The amount of captured taxable value estimated to result from adoption of the Plan is reasonable, 4. Approval and Adoption of Plan. The Plan as submitted by the Authority is hereby approved and adopted. A copy of the Plan and all amendments thereto shall be maintained on file in the City Clerk's office. 5. Establishment of Project Fund: Approval of Depositary. The Authority shall establish a separate fund for the Eligible Property subject to this Plan, which shall be kept in a depositary bank account or accounts in a bank or banks approved by the Treasurer of the City. All monies received by the Authority pursuant to the Plan shall be deposited in the Project Fund for the Eligible Property. All monies in the Project Fund and earnings thereon shall be used only in accordance with the Plan and Act 381, 6. Use of Monies in the Project Fund. The monies credited to the Project Fund and on hand

therein from time to time shall be used annually to first make those payments authorized by and in accordance with the Plan and any development. 7. Payment of Tax Increment Revenues to Authority. The municipal and the county treasurers shall, as ad valorem and specific local taxes are collected OI') the Eligible Property, pay the Tax Increment Revenues to the Authority for deposit in the Project Fund. The payments shall be made not more than 30 days after the Tax Increment Revenues are collected. 8. Disclaimer. By adoption of this Resolution and approval of the Plan, the City assumes no obligation or liability to the owner, developer, lessee or lessor of the Eligible

Property for any loss or damage that may result to such persons from the adoption of this Resolution and Plan. The City makes no guarantees or representations as to the determinations of the

appropriate state officials regarding the ability of the Authority to capture tax increment revenues from the State and local school district taxes for the Plan. 9. Repealer. All resolutions and parts of resolutions insofar as they conflict with the provisions of this resolution shall be rescinded. [NOTE: Pursuant to the resolution establishing the Authority and the bylaws of the Authority, the COF Brownfield Redevelopment Authority has approved a proposed brownfield plan for the Carriage Town Neighborhood Project

(the "Plan") at their meeting on August 8th, 2023. The required notice of the public hearing on the proposed Plan was given in accordance with Section 13 of Act 381, and such hearing will be held by City Council on October 4th, 2023. high quality, affordable energy-efficient housing. This project has received an acquisition rehabilitation commercial loan from ELGA Credit Union and will be receiving local and state subsidies. The proposed bedroom mix is (1) 2 bed/1 bath, (1) 2 bed/1.5 bath, (3) 1 bed/1 bath. Scope of work and planned improvements include a complete renovation of interior and exterior of building. This refers to the replacement of windows, doors, flooring, appliances, cabinetry, and fixtures. In addition, bathroom and kitchen renovations are planned for all units. HVAC will be replaced for the building. Walls will be scrapped and repainted for all units. The exterior siding will be repaired, along with gutters and roof replacement. The insulation will be upgraded. The fireplace on the first level may be repaired. The property is currently unoccupied in Ward 5.

<u>History:</u> The mission of Communities First, Inc. is to build healthy, vibrant communities through economic development, affordable housing and innovative programming. Founded in 2010 by Glenn and Essence Wilson, Communities First, Inc. has grown extensively in just a few short years. As Flint natives who are passionate about their hometown, it only made sense to focus their efforts on the Flint area. The combination of their skills with those of a dedicated board of directors has allowed Communities First Inc. to do great work in the Flint community. <u>Past projects</u>: The first project that the organization took on was the Oak Street Senior Apartments, formerly known as Oak School in Flint, Michigan. This \$5.1 million project has opened the doors for future projects and is a great starting point for Communities First, Inc. <u>Desired Outcome:</u> This project seeks to alleviate the profound demand for quality, safe, affordable housing, especially for those affected by the COVID-19 pandemic, while also providing housing for middle-income levels. Our recently completed projects, Coolidge Park Apartments and Berkley Place Apartments, have more demand than units available. We seek to offer 716 S Grand Traverse as a desirable affordable housing option that is high-quality, safe, and healthy.

Genesee County Habitat for Humanity: Funding request and purpose: Requesting \$150,000 for Sylvan Court Almost Home Project: The Sylvan Court Project helps families to create optimal outcomes by combining a hand up through our Almost Home Program with homeownership opportunities close to Flint's growing Downtown. Sylvan Court is an 8-unit development comprising 4 townhomes and 2 sets of duplexes with a landscaped southern gateway to Memorial Park between them. The four townhomes were completed in 2021 and house the Almost Home Program to help families who currently don't qualify for homeownership achieve their goal. The 2 sets of duplexes will be condomized and sold as individual units. They will be accessible for people with disabilities and will include a 1st floor bed and bath. Priority for these units will be given to prospective homeowners that are physically impaired or are taking care of someone that is physically impaired. The City of Flint has committed \$442,348 in HOME funds and CHDO allocations, and an additional CHDO application has been submitted to support the project. Also \$74,200 in SHOP funds have been applied for through Habitat for Humanity International. GCHFH will also use funds from the sale of previous homes to support remaining gap funding.

History: Founded in 1990, Genesee County Habitat for Humanity (GCHFH) is one of nearly 1,400 United States affiliates of Habitat for Humanity International. Habitat for Humanity partners with people in your community, and all over the world, to help them build or improve a place they can call home. Habitat homeowners help build their own homes alongside volunteers and pay an affordable mortgage. With your support, Habitat homeowners achieve the strength, stability and independence they need to build a better life for themselves and for their families. Through our 2020 Strategic Plan, Habitat for Humanity will serve more people than ever before through decent and affordable housing. We provide affordable homeownership opportunities and can benefit minority populations that have been disproportionately impacted by COVID19 in several ways. More than 70% of the families GCHFH serves are minority populations that have been disproportionately impacted by COVID19. Habitat for Humanity works in more than 70 countries. Our advocacy efforts focus on policy reform to remove systemic barriers preventing low-income and historically underserved families from accessing adequate, affordable shelter. Past Projects: Habitat for Humanity of Genesee County began in 1999 and is currently working on its 25th home. Desired Outcomes: Overall,

affordable homeownership opportunities can provide a range of benefits for minority populations that have been disproportionately impacted by COVID19. By building wealth, providing stability, and increasing access to credit, homeownership can help to mitigate some of the economic challenges faced by these communities during the pandemic.

**Young Men's Christian Association of Flint (YMCA):** Funding request and purpose: **Requesting \$200,000 for** The Harrison Street Project is a redevelopment of a previously vacated space located at the corner of East 3rd Street and Harrison Street into a mixed-use building with affordable housing and community center. This project will increase vitality and vibrancy around downtown and attract new residents, visitors, and businesses to Flint. Located across the street from the MTA bus station, this location is prime for Flint residents and visitors alike with its ease of access from public transportation and connection to new housing options. The five-story structure will combine 50 units of a residential rental housing complex managed by Uptown Reinvestment Corporation (URC) and a newly constructed 50,000 square foot Downtown YMCA Branch (the Y.) The Y's community entrance will include an aquatic center, gymnasium, cardio and weight rooms, gender neutral bathroom and changing areas, and common rooms for community partners. Although we have secured nearly \$39,000,000 in funding, we still have a gap of \$1.6 million to fully fund the project. Our market research shows us that we can expect to increase our membership with a new facility. This would result in over 1,600 additional new members coming to Downtown Flint on a regular basis, strengthening not only themselves, but also our community through the economic impact of increasing traffic and visits to local restaurants, shops, and markets.

History: The YMCA is the leading nonprofit committed to strengthening community by empowering young people, improving the health and well-being of people of all ages and inspiring action in and across communities. This project greatly benefits minority populations in the local community. Sixty-four percent of the members who use the Downtown YMCA identify as African American, Hispanic, Pacific-Islander or Native American. We serve Ward 1; Ward 2; Ward 3; Ward 4; Ward 5; Ward 6; Ward 7; Ward 8; Ward 9. Past Projects: The Y gives kids, adults and families an opportunity to get involved with community-based service projects that make a real difference. Whether it's planning a food drive, leading a cleanup effort or contributing to a community garden, together, everyone can help build a stronger community. Desired Outcomes: The project will improve the health and wellness of Flint residents by offering programs and amenities that address chronic disease, obesity, and mental health. Residents will recreate year-round, participate in group exercise, healthy eating, and health education classes. Families will find a facility that embraces whole-family fitness and education. The facility will also include the only functional swimming pool in the city of Flint that allows youth without requiring membership to the facility. The project will also provide economic development by attracting new visitors to Flint.

McFarlan Villages: Funding request and purpose Requesting \$150,000 awarded \$125,000 for McFarlan Villages is to expand quality and affordable housing in Flint, directly affecting the older adult minority population. Eight Hundred (800) E. Court Street is home to over 149 older adults 55 and older, with the average resident being 67 years old. Of these residents, 78% identify as part of a racial minority population.

<u>History-</u> McFarlan Villages located at 700 E. Kearsley Street Flint, MI 48503 is committed to providing quality, affordable housing solutions for seniors. Our portfolio of properties includes housing for senior women in an assisted living facility and apartments for those who desire a more active lifestyle. McFarlan Villages is backed by a private foundation which allows it to provide innovative amenities and services to the residents it serves – all at the most competitive pricing available. When you are looking for senior living with a difference, consider a McFarlan Residential property. With all the features and amenities this truly is senior living simplified. The mission of McFarlan is to maximize opportunities for quality of life by providing safe and affordable housing and caring services for diverse older adults in the greater Flint community.

McFarlan Villages: Funding request and purpose: Request \$150,000 awarded \$125,000 in ARPA funding, to revitalize McFarlan Village's 700 E. Court Street property to attract and retain older adults in the community. By increasing the number of affordable housing units and creating a continuum of senior care, older adults can age in place in the heart of Flint and remain independent for as long as possible. In addition, aging in place costs significantly less than the alternative of moving to a nursing home. Currently, the closest community that offers all levels of care on one campus for older adults with low incomes is 70 miles away in the City of Detroit. This continuum of care will have different levels of health care, all on one campus. Creating a continuum of care near downtown Flint affords older adults a better quality of life with social networks and support systems, wellness activities, preventative health care, and managing disease through our onsite senior health center. All of these reduce unnecessary and costly hospitalizations. Desired Outcomes: Enrich Fairfield Village, the College Cultural Center, and Flint's downtown, keeping it diverse, economically strong, and attractive by: increasing affordable senior housing improving older adults' access to healthcare, increasing access to technology and the internet, introducing environmentally friendly building practices, and energy-efficient appliances, introducing attractive buildings and grounds to help beautify the gateway to downtown Flint and the College Cultural Center area.

**Catholic Charities of Shiawassee and Genesee County:** Funding request and purpose: **Requesting \$500,000 awarded \$400,000** We have begun the process to build a tiny home community at 719 E. Moore St. called Sacred Heart Village, to provide safe and affordable housing for and underserved members of the community. The funds will be used to prepare the land we own to build future phases of this program. We have the funding and scheduled services to be shovel ready prior to December 2024 for this phase of the program. This funding will cover most of the costs for excavation bringing central sewer, water, and power to the property in anticipation of the placement of twenty-six homes. This proposal is an opportunity for Flint to be an inspiration to communities across the United States looking to address housing concerns for underserved populations. This project will be the second Tiny Home community in Michigan and Catholic Charities has the reputation and longevity to bring together the support and resources to make it a success.

History- Catholic Charities of Genesee and Shiawassee Counties is a private, non-profit 501 C 3 organization. The Agency was established in 1941. The idea to start up the Agency was formulated in the 1930's when the residents of Flint strained under the burdens of rapid population growth and many people started to experience the struggles of the Great Depression. Past projects- In Fall of 2017, the Agency opened their Center for Hope to the public. The Sr. Claudia Burke Center for Hope, named after the Sister Claudia, who had once worked at Catholic Social Services, which later become Catholic Outreach, whose entire mission was to serve the poor and most vulnerable, which is what the Center for Hope accomplishes. Desired Outcomes: The Village will offer comprehensive services to help participants regain stability and thrive. These services will include counseling, suicide prevention, case management, employment services, financial literacy training, substance abuse treatment, and on-demand Veteran services. The Sacred Heart Village will provide a sense of community to those who have been marginalized, isolated and underserved because it will include a Community Center and garden. This will help participants develop relationships with their neighbors. This comprehensive approach will ensure that participants in the program have access to the resources they need to become self-sufficient.

Latinx Technology and Community Center: Funding request and purpose: Requesting \$175,000 The mixed-use project for the Berlanga building characterizes development strategy as one that 1) provides three or more significant revenue-producing uses; such as early education, leasable office space supporting authentic Latinx businesses, and organizations), 2) fosters integration, density, and compatibility of land uses, and 3) enhances a walkable community with uninterrupted pedestrian connections. The proposed LTCC project is directly aligned with the recommendations set forth by the State of Michigan's - Coronavirus Task Force on Racial Disparities by developing a mixed-use project offering early education and leased office space for youth social/emotional programs.

History: Latinx is an inclusive term to all genders, and it is an alternative term for Latino and Latina. In 2019, the Board of Directors evolved the long-established organizational name and ethnic identifying term from Hispanic to Latinx. Defined and recommended by the youth leadership program participants, the organizational leadership envisioned a community center that represents and reflects the diversity of the community it serves. Throughout the last decade, the Latinx Technology & Community Center (LTCC) has been engaged with neighbors and community leaders on the Eastside of Flint to support blight elimination and productive reuse of vacant spaces. LTCC has been a long-time participant in the Land Bank's Clean & Green Program and has purchased and revitalized several vacant lots near the LTCC building. Past Projects: In 2018, LTCC completed a revitalization of two adjacent vacant lots, creating a neighborhood pocket-park and revitalizing a busy bus stop used by many LTCC clients and the community. This project launched a greater interest and commitment from the LTCC Board of Directors and community in pursuing more significant revitalization of the surrounding area—with a long-term vision of transforming Lewis Street into Flint's Latinx District. <u>Desired Outcomes:</u> In 2021, LTCC initiated the purchase of the vacant "Berlanga" building in the Lewis Street Corridor that when developed appropriately, will act as a tipping point for attracting new investment and residents to the Latinx District, and other locations throughout the City of Flint. The redevelopment strategy fosters community design that addresses the economy, community, public health, and educational outcomes of the surrounding neighborhood.

# RESOLUTION TO PROCEED WITH ARPA FUNDS GRANTS FOR ALTERNATIVE USES OF VACANT LOTS

The City of Flint is a duly created and validly existing political subdivision of the State of Michigan under the Constitution and laws of the state of Michigan, and;

On March 11, 2021, the President of the United States of America signed into law the "American Rescue Plan Act of 2021", also known as House Resolution 1319, an Act approved by the Congress of the United States, and which authorized the Treasury of the United States to disburse certain funds to local governments, including the City of Flint, which could be used for specific and defined purposes, and;

In accordance with the American Rescue Plan Act of 2021, the City of Flint wishes to exercise its right to extend and disseminate assistance to impacted households tied to specific criteria, as authorized by the Act, to assist citizens who may have been impacted financially by the ongoing COVID-19 Pandemic.

The administration recommends funding the Grants for Alternative Uses of Vacant Lots contracts in the amount of \$350,000 from the category of Blight and Housing # HB06 as part of City Council Resolution 220464.1, Proposed ARPA Allocation Plan, on October 24, 2022. The information can also be found under the Blight and Housing tab on the excel spreadsheet provided by E&Y.

According to the City of Flint ARPA plan, the desired outcomes for this category are:

- Decreased blighted structures.
- Decrease migration out of Flint.
- Increased property values.
- More diverse housing options.

Below is a chart of the Ad-hoc Committee recommendations (highlighted in orange). Mayor Neeley and the administration were tasked with adjusting the amounts awarded and the selected organizations to make sure that the amount funded matched the council approved budget amount. ## RESOLUTION TO PROCEED WITH ARPA FUNDS GRANTS FOR ALTERNATIVE USES OF VACANT LOTS

### **Background/Summary of Proposed Action:**

Active Boys in Christ: Funding request and purpose: Requesting \$100,000 for ABC Youth Program ABC Youth non-profit organization plans to use 2701 Branch Rd. vacant lot to develop the outdoor space of a youth training center for ages 7-17. The center would be used as a workspace to help eliminate blight in our neighborhood, as students will explore careers in skilled trades, academic tutoring, and enrichment activities.

This property was formerly a mobile home park that has been a dumping site for several years. Active Boys in Christ purchased this property in February 2022 and cleared all the debris that was dumped over several years. They demolished a dilapidated building, removed 30 concrete mobile home pads, and cleared all the brush.

ABC Youth plans to develop a portion of the property into a community garden, outdoor play area, and a full outdoor basketball court. This project would help develop the whole child by creating a healthy and safe environment for youth to explore and engage in activities. Children who have access to healthy food are more likely to have higher levels of academic achievement, better mental health outcomes, and improved physical health outcomes. (Source: Centers for Disease Control and Prevention, https://www.cdc.gov/healthyschools/nutrition/facts.htm). Furthermore, children who are physically active are more likely to have higher levels of academic achievement, improved cognitive function, and better mental health outcomes. (Source: Centers for Disease Control and Prevention, https://www.cdc.gov/healthyschools/physicalactivity/facts.htm). According to the MiSchool Data, 94% of the children in Flint, MI are not proficient in ELA in fourth grade, as compared to the state average of 36%. In addition, 94% of children are not proficient in Mathematics in third grade, as compared to the state average of 58%. Thus, this project will contribute to improved physical health and well-being of community members, access to healthy food, reduced violence, scholastic competence, academic success, and safe community engagement.

History: Active Boys in Christ is a nonprofit 501©(3) organization founded by Derrick Watkins in 2017. It's main purpose is to expose the youth in the Flint Community to the career opportunities found in Skilled Trades. Derrick's desire to start the program was birthed from his own childhood experience. Growing up in the Flint and Beecher Community, he understood that Flint kids didn't have the same opportunities or access to resources as those in different districts, cities, and towns. He was always told, "if you don't go to college, you will be working at a Fast food restaurant for the rest of your life." Derrick knew college wasn't for everyone. "Our youth in Flint need career options and we want to give them the opportunity and information to be successful in their career of choice. As Frederick Douglass said, "It is easier to build strong children than to repair broken men." That's how Active Boys in Christ came about."

Friends of Berston: Requesting \$125,000 for Site Improvement Project; The current Berston Field House is almost 100 years old and during that time it has never enlarged its building footprint, even though the programs provided at this facility have changed and expanded. The building project being developed includes a 57,000 sf addition to include a new large tournament size gymnasium with locker rooms, a walking track, and a fitness center. The new addition will also include a connecting link to the existing building that has an elevator and stairway to access all floor levels of the new addition and the old building. It also includes a large new entry that contains a Hall of Fame highlighting the achievements of previous participants at Berston. The existing building will be totally remodeled, including its mechanical and electrical systems and will provide classrooms for after-school education, computer access for those in the community, art classes and bicycle training and repair. The one existing gym will be remodeled into a flexible community center and the other gym will be remodeled into two dance studios serving the young and old in the Flint area. The old locker rooms will become the new location for the boxing center and the upper level will be converted into the Berston administrative offices. The project also includes expansion of the Berston site from 6.85 acres to 14.60 acres by purchasing an abandoned church property to the northeast and vacant residential property to the south. With this additional property Berston will move the current softball field and outdoor basketball courts, add much needed on-site parking, add a Little League baseball field, a football/soccer/lacrosse field, pickleball courts, playgrounds, a splashpad and add an outdoor amphitheater venue for summer concerts. This particular grant will be used solely for site improvements and the demolition of the existing abandoned buildings on the site to build the new baseball diamond and soccer field.

History: Friends of Berston (FOB) was formed in 2014 as a non-profit, housed in the historic Berston Field house to keep the facility operational. At that time, the City of Flint was no longer financially able to keep its recreational and community centers open, due to its insolvency. Berston Field House was built in 1923 on land donated by children of Flint land developer and philanthropist, Neil J. Berston. Mr. Berston, at the turn of the century, had the foresight to buy and transform farmland into the residential neighborhoods surrounding what is now Berston Field House. The field house was named in honor of this generous visionary, and after 94 years of existence, the building remains structurally sound as is Berston's place in the community among its patrons who range from the very young to senior citizens. The field house is just north of downtown Flint. When initially built, Berston was a state-of-the-art field house. As stated earlier, it is still structurally sound, but in need of some renovations. Friends of Berston, through the hard work of its board of directors and its current executive director, Bryant Nolden (who initially was its volunteer director for about 6 years) secured funding from private foundations and individual donors. That funding now provides Berston Field House a paid executive director—Bryant Nolden, who has proven himself to be a dedicated administrator. The funding also provides him an executive assistant, a grant coordinator, and an events coordinator.

Friends of Berston's Mission Statement is: Enhancing the impact of Berston through quality education, athletics, the arts, and comprehensive social services. This mission is in keeping with all that Berston Field House has been in the past for the community in which it is situated. In the past, it offered a wide range of sports which included swimming—the pool was removed several years ago. It had a branch of the Flint Public Library inside, as well as a small medical clinic to assist those who were unable to afford medical services. Friends of Berston does not want to just maintain Berston for now but plans to restore it to its former glory for future generations to enjoy as well.

Currently, patrons can participate in sports, a variety of dance classes which includes senior line dance classes, arts and crafts, and even chess. Plans are in place to house a success center within the field house where patrons in need of honing their literacy skills can come for assistance. Friends of Berston truly intends to carry on the tradition of Berston Field House for all its patrons.

Communities First: Funding request and purpose: Requesting \$25,000 for Food Truck Park Project: Located a couple blocks west of downtown in the Grand Traverse Neighborhood, there is a vacant lot where a building once stood. With these funds, Communities First, Inc. (CFI) proposes the transformation of this underutilized space into the third and final phase of our project – Foodie Commons @ the Flowershop.

Envisioned as Flint's first dedicated food truck park, Foodie Commons will offer supports for small businesses, flexible community gathering spaces for events like neighborhood meetings and amenities for all seasons. Combined with CFI's committed renovations to the abandoned flower shop building and parking lot next door, the development of this vacant lot will offer Flint a permanent food truck park, covered seating, an outdoor entertainment space, a grass lawn that can be used by families for free play and exercise as well as host innovative programming like our annual Movies Under the Stars event. Paved pathways and intentional seating will also ensure that the space is accessible for everyone.

CFI anticipates the space will welcome 1,600+ community members in its first year of operation. Additional project outcomes will include: Engaging at least 10 food truck operators who are Flint residents and/or include historically underrepresented demographics in entrepreneurship like women, racial/ethnic minorities, etc. Technical assistance and resource support utilized by 10 small business owners. \$75,000+ in revenue generated in food truck sales.10+ free programs and events offered annually to the Flint community such as artistic performances, cross-cultural explorations, resource fairs, and more. Collaboration with at least 5 community organizations who will host events of their own on the site. With the support of these funds, this investment will have a positive, rippling effect on the local economy and strengthen cultural life in Flint.

History: The mission of Communities First, Inc. is to build healthy, vibrant communities through economic development, affordable housing, and innovative programming. Founded in 2010 by Glenn and Essence Wilson, Communities First, Inc. has grown extensively in just a few short years. As Flint natives who are passionate about their hometown, it only made sense to focus their efforts on the Flint area. The combination of their skills with those of a dedicated board of directors has allowed Communities First Inc. to do great work in the Flint community. Past projects: The first project that the organization took on was the Oak Street Senior Apartments, formerly known as Oak School in Flint, Michigan. This \$5.1 million project has opened the doors for future projects and is a great starting point for Communities First, Inc. Desired Outcome: This project seeks to alleviate the profound demand for quality, safe, affordable housing, especially for those affected by the COVID-19 pandemic, while also providing housing for middle-income levels. Our recently completed projects, Coolidge Park Apartments and Berkley Place Apartments have more demand than units available. We seek to offer 716 S Grand Traverse as a desirable affordable housing option that is high-quality, safe, and healthy.

NEH: Carriage Town Neighborhood Assoc.: Funding request and purpose: Requesting \$25,000 for Playground project: This project will occur within the Historic Carriage Town Neighborhood on the block's interior bounded by 2nd Ave. (north), 1st Ave. (south), Grand Traverse (west), and Mason St. (east). The interior of this block is home to an informal pocket park where residents and neighborhood association members host pop-up events during the year. 3,574 people live within a 10-minute walk of this block. While numerous parks are near the neighborhood, none offer play equipment for children and families. During the covid-19 pandemic, residents created this pop-up space to support social gatherings with live music, games, and local vendors.

*Project Activities:* Carriage Town residents and the association seek to further enhance the space by constructing wooden playground amenities and installing benches, trash cans, and picnic tables.

Project Outcomes: The Carriage Town pocket park is an ideal space between well-maintained and recently restored homes. The pocket park adds value to the neighborhood and makes the newly rehabbed homes even

more attractive. Children and families that live in the area will have a well-maintained public space for leisure and play.

<u>History:</u> The Carriage Town Historic Neighborhood Association was formed in 1982 as an attempt by local preservationists and business owners to prevent further decay of the neighborhood where Water Street carriage factory workers typically lived.

<u>Hispanic Technology Center</u>: Funding request and purpose: Requesting \$25,000 for Pavilion and Picnic Table Project.

In 2018, LTCC completed a revitalization of two adjacent vacant lots, creating a neighborhood pocket-park and revitalizing a busy bus stop used by many LTCC clients and the community. This project launched a greater interest and commitment from the LTCC Board of Directors and community in pursuing more significant revitalization of the surrounding area—with a long-term vision of transforming Lewis Street into Flint's Latinx District. As a first step in this process, LTCC engaged the Neighborhood Engagement Hub (NEH) to support a community engagement process to work with residents to identify projects and priorities to pursue through an Action Plan. Utilizing the initial results from the neighborhood engagement meeting, LTCC identified priority projects to enhance the neighborhood in ways that respect the community's wishes and create new economic opportunities and improve quality of life through supporting authentic Latinx businesses, organizations, and stakeholders in the community. In 2021 LTCC leveraged funds to purchase a highly desired development project for a community playground to the lot immediately adjacent to LTCC's Resource Center and "Berlanga" building. The playground installation was completed in November 2022 with an anticipated Spring 2023 ribbon cutting ceremony. The Grants For Alternative Uses Of Vacant Lots project proposal leverages the momentum of the recent "Community Playground" development project with the addition of a shelter, commercial picnic table(s), and community grill in the adjacent vacant lot.

<u>History:</u> History: Latinx is an inclusive term to all genders, and it is an alternative term for Latino and Latina. In 2019, the Board of Directors evolved the long-established organizational name and ethnic identifying term from Hispanic to Latinx. Defined and recommended by the youth leadership program participants, the Administration 10/15/2023 organizational leadership envisioned a community center that represents and reflects the diversity of the community it serves. Throughout the last decade, the Latinx Technology & Community Center (LTCC) has been engaged with neighbors and community leaders on the Eastside of Flint to support blight elimination and productive reuse of vacant spaces. LTCC has been a long-time participant in the Land Bank's Clean & Green Program and has purchased and revitalized several vacant lots near the LTCC building.

Mott Community College: Funding request and purpose: Requesting \$50,000 for Clark Commons Garden and Park Project. MiBlock810 will serve the residents of Clark Commons and Smith Village neighborhoods which currently consists of approximately 165 households with an additional 48 units near completion. These funds will be used to make improvements to enhance the neighborhood and strengthen relationships between residents as well. They will identify resident advocates and develop work groups that will come together to complete projects for the vacant land, which includes the following: Develop a community garden (including fruit trees), Create a small park, which can include recreational space, seating and art. Develop an outdoor exercise area for outdoor yoga (exercise) during weather permitting months. Create a walking path. Establish pollinating spaces, plant flowers and trees. This project will benefit the residents of Smith Village/Clark Commons, in a number of ways, it will help offset the cost of vegetables, it will allow for them, space to relax in their neighborhood, and will help their overall mental well being. It will also give the residents a place to go for an opportunity to get to know their neighbors better. This will help create a sense of community which is a key factor in people feeling safe and comfortable in their neighborhoods.

<u>History:</u> The mission of Mott Community College is to provide high quality, accessible, and affordable educational opportunities and services that cultivate student success and individual development and improve the overall quality of life in a multicultural community.

Through the utilization of a specific rubric and review/scoring process, 5 of the 12 applications as well as an additional recommendation for Disability Network for accessibility modifications totaling \$4,625,000 have been chosen by the Mayor for recommendation for funding. These selected organizations address community priorities, meet eligibility requirements, are backed by evidence of effectiveness, promote equitable outcomes, leverage other dollars, and are financially sustainable.

To be eligible for these grants, homeowners need to have been in their house for atleast one (1) year, be under 300% of the federal poverty level depending on their household size and be in good standing with the City of Flint (water bills and property taxes paid). Lower-income households will take priority over households with greater levels of income. 

### RESOLUTION APPROVING AMENDMENT OF WASTE COLLECTION SERVICES CONTRACT WITH PRIORITY WASTE LLC

On September 7, 2021, City Council adopted Resolution #210367, authorizing a contract with Priority Waste LLC for waste collection services covering FY2022, FY2023, FY2024, and part of FY2025.

The City of Flint has recently received two grants to purchase trash and recycling carts totaling \$3,492,000.00. To implement those grants and avoid the need to return those grant funds, the City must amend the contract with Priority Waste LLC to facilitate the use of those trash and recycling carts, which are outside the scope of the original contract.

Priority Waste, LLC has agreed to amend the current contract to extend the term of the contract through June 30, 2028, remove the current contract provisions establishing rate increases for those years, extend the third-year (FY2024) rates through FY2028, and provide for an optional five (5) one-year contract extensions to cover FY2029, FY2030, FY2031, FY2032, and FY2033 at agreed-upon rates.

IT IS RESOLVED that the proper City officials are authorized to execute a change order to the contract with Priority Waste, LLC, extending the term of the contract to June 30, 2028, with the third-year rates to be extended through that period, in an amount not to exceed \$26,889,631.20 (aggregate amount \$46,616,378.40).

### BACKGROUND/SUMMARY OF PROPOSED ACTION/FINANCIAL IMPLICATIONS:

The City of Flint has been preliminarily awarded two grants for City of Flint residents for the procurement and distribution of recycling and trash carts, educational materials, and outreach efforts. To support the implementation of a cart program, the contract with Priority Waste must be amended to support this program. Priority Waste has agreed to extend the current contract until June 30, 2028, with five one-year options to extend, and will lock in pricing at the current third-year rate through June 30, 2028. After that date, the one-year options include guaranteed pricing at a 3% increase per year.

In comparison, the current contract provides for price increases beginning in FY2025. The total costs for FY2025-FY2028 will save the City of Flint over \$2.2 million dollars. In addition, if the contract with Priority Waste is not amended, the City will have to return the approximately \$2.5 million in grant funding that it has received to fund this cart program.

### **Background/Summary of Proposed Action:**

R.L. Jones Community Outreach Center: Funding request and purpose: Requesting \$100,000 for Access and Functional Needs Program; Since the Water Crisis, R.L. Jones Community Outreach Center has served as a Help Center/ Resource Center for seniors and families to receive water and food. R.L Jones Community Outreach Center assists residents in 1,364 households weekly through their Access and Functional Needs (AFN) delivery service. The AFN Program Delivery Services division provides critical resources to citizens at their place of residence. The need for water delivery for seniors over the age of 85 has increased since the COVID-19 pandemic. They are continuing to provide foods high in protein and foods high in various vitamin nutrition. They also partner with GCCARD and the Food Bank of Eastern Michigan to purchase the various supplies used for our food distribution services.

The items distributed through all divisions have expanded including an increase in requests for cleaning and personal care items. They are now providing detergent, disinfectant cleaning supplies Clorox, Lysol Wipes, Hand Sanitizer, etc. Families show an increased need for baby food, toothpaste, bath soap, deodorant, milk, diapers, adult diapers, shampoo, conditioner, mouthwash, snacks, etc. While many of the residents they service are seniors through our AFN Delivery, many of them care for grandchildren and other young family members which increases the need for essentials for small children and babies.

In their area, normally senior citizens and the disabled do not get very good access to public transportation allowing them to get to a store to pick up everyday household items. In addition, their area of the city has no regular grocery stores that are within walking distance for many residents. Therefore, there was a huge need to have items brought to them which is what led to the development of the Access and Functional Needs Program. The senior population is particularly vulnerable to rising costs. Too many seniors are having to choose between purchasing prescriptions versus food, so they can step in to fill that gap and provide them with nutritious foods ensuring they no longer have to pick food or medication. There are definite health inequities that exist for these particularly vulnerable populations regarding food access. R.L. Jones Community Outreach Center works to address these inequities through the services we provide in the community.

### History:

For over 50 years, Greater Holy Temple Church Of God In Christ has been a landmark in North Flint and is the home of the R.L. Jones Community Outreach Center (COC) which was established in 2016. The Center is dedicated to the promotion and maintenance of optimal health and wellness for residents affected by the Economy, Water and COVID-19 Crisis and beyond.

They have four priority service areas: The Catherine's Closet of Hope, Access and Functional Needs Home Deliveries (AFN), Youth in Action and Adult Job Training Program (Job Readiness Program) and a Resource Center that includes Health and Wellness, Social Services and Food Distribution and Nutrition.

They are dedicated to the promotion and maintenance of optimal health and wellness for patients dealing with short-term illnesses, rehabilitation and recovery during the food insecurity crisis in Flint and the surrounding areas. The COC-Nutrition Center is located on the Northside of Flint, Michigan; and is a convenient and trusted resource hub for individuals seeking a holistic approach to address the effects of food insecurity and lead poisoning on their health and well-being.

The Resource Help Center provides weekly food distribution on Thursdays. Through our HELP Center we assist an average of 300 vehicles which equates to approximately 900 residents per week.

Families who receive SNAP benefits recently saw reductions in the COVID-19 emergency food assistance payments which they had been receiving. These families have been turning to the HELP Center to get food which was previously covered by their increased SNAP benefits. In addition, many of the families we service are not eligible for these benefits. They come from working class homes whose incomes are higher than the allowable amounts. As costs for goods have increased there has been a dramatic rise in health disparities regarding families being eligible to purchase healthy foods, so the HELP Center has helped fill this gap.

### **Background/Summary of Proposed Action**

Good Church: Funding request and purpose: Requesting \$100,000, awarded \$50,000 for Serve Flint Program; Serve Flint is a program housed at Good Church that makes neighborhood beautification the priority and standard in the community that they serve. With over 400+ volunteers, they are able to maintain many of the vacant lots in the one mile radius that surrounds their physical address, 1034 East Holbrook Ave. Over the past two years they have been able to purchase and maintain 16 vacant lots that surround them. They have also applied for ownership of 30 additional vacant lots in our one mile radius. Serve Flint conducted a clean up day where they impacted 20 neighborhood homes, and 30 vacant lots on May 1st 2022. Over 400 volunteers tackled major community blight problems and provided repairs for community homeowners, free of charge. The neighborhood was also provided with a number of dumpsters placed throughout the one mile radius so that residents could dispose of larger trash items without participating in illegal dumping. This clean up day is scheduled again for May 21, 2023. While this project made a lasting impact, Serve Flint operates year round to provide neighborhood beautification to the residents in this community. They have currently placed a permanent dumpster on our property to assist with illegal dumping, we provide minor home repairs to neighbors free of charge, as well as seasonal clean up for those not able to physically take care of their own property.

<u>History</u>: Good Church is a multicultural community that impacts as many lives as we can with the life-giving message and love of Jesus. As a People and as a multicultural church, they are seeking to enrich the lives of others that they encounter daily. During the height of Covid-19, Good Church participated in food distribution events at surrounding apartment complexes, and during this time the church also realized that there was a need for a community Laundromat. While the Good Church is focusing on blight elimination they are also in process of creating a community laundromat called "Good Laundry".

#### **Background/Summary of Proposed Action:**

**Catholic Charities of Shiawassee and Genesee County:** Funding request and purpose: Requesting \$500,000 awarded \$400,000 They have begun the process to build a tiny home community at 719 E. Moore St. called Sacred Heart Village, to provide safe and affordable housing for underserved members of the community. The funds will be used to prepare the land they own to build future phases of this program. They have the funding and scheduled services to be shovel ready prior to December 2024 for this phase of the program. This funding will cover most of the costs for excavation bringing central sewer, water, and power to the property in anticipation of the placement of twenty-six homes. This proposal is an opportunity for Flint to be an inspiration to communities across the United States looking to address housing concerns for underserved populations. This project will be the second Tiny Home community in Michigan and Catholic Charities has the reputation and longevity to bring together the support and resources to make it a success.

<u>History-</u> Catholic Charities of Genesee and Shiawassee Counties is a private, non-profit 501 C 3 organization. The Agency was established in 1941. The idea to start up the Agency was formulated in the 1930's when the residents of Flint strained under the burdens of rapid population growth and many people started to experience the struggles of the Great Depression.

<u>Past projects-</u> In Fall of 2017, the Agency opened their Center for Hope to the public. The Sr. Claudia Burke Center for Hope, named after the Sister Claudia, who had once worked at Catholic Social Services, which later become Catholic Outreach, whose entire mission was to serve the poor and most vulnerable, which is what the Center for Hope accomplishes.

<u>Desired Outcomes:</u> The Village will offer comprehensive services to help participants regain stability and thrive. These services will include counseling, suicide prevention, case management, employment services, financial literacy training, substance abuse treatment, and on-demand Veteran services. The Sacred Heart Village will provide a sense of community to those who have been marginalized, isolated and underserved because it will include a Community Center and garden. This will help participants develop relationships with their neighbors. #### BACKGROUND/SUMMARY OF PROPOSED ACTION/FINANCIAL IMPLICATIONS:

In 2010, the City Council opted the City out of sale of alcohol between the hours of 7AM and noon on Sundays, as permitted by Public Act 213 of 2010. Since that time, multiple other localities in Genesee County have permitted such sales, such that the City's businesses are placed at a competitive disadvantage.

Repealing Resolution 101308 will allow the City's restaurants and retailers to apply for Sunday Sales Permits from the Michigan Liquor Control Commission and compete on a more even playing field.

WHEREAS, The Liquor Control Commission has set a deadline of December 15, 2010 to receive the resolution from the City of Flint;

**THEREFORE BE IT RESOLVED**, That the Flint City Council, as the governing body of the City of Flint, prohibits sales of beer, wine, spirits, mixed spirits, and liquor between the hours of 7 a.m. on Sunday until 12 noon on Sundays.
