RESOLUTION APPROVING AMENDMENT OF WASTE COLLECTION SERVICES CONTRACT WITH PRIORITY WASTE LLC

On September 7, 2021, City Council adopted Resolution #210367, authorizing a contract with Priority Waste LLC for waste collection services covering FY2022, FY2023, FY2024, and part of FY2025.

The City of Flint has recently received two grants to purchase trash and recycling carts totaling \$3,492,000.00. To implement those grants and avoid the need to return those grant funds, the City must amend the contract with Priority Waste LLC to facilitate the use of those trash and recycling carts, which are outside the scope of the original contract.

Priority Waste, LLC has agreed to amend the current contract to extend the term of the contract through June 30, 2028, remove the current contract provisions establishing rate increases for those years, extend the third-year (FY2024) rates through FY2028, and provide for an optional five (5) one-year contract extensions to cover FY2029, FY2030, FY2031, FY2032, and FY2033 at agreed-upon rates.

# RESOLUTION TO ALLOCATE OPIOID SETTLEMENT FUNDS FROM THE STATE OF MICHIGAN, IN THE AMOUNT OF \$50,000

#### **Background/Summary of Proposed Action:**

Name and type of organization: Donations with Love Foundation - a 501(c)3 Organization

Expected timeline for expansion activities: December 1, 2023 – November 30, 2024 Amount of funds requested: \$50,000.

<u>History-</u> The Donations with Love Foundation (DWLF) was established in 2015 to serve young people between 7 and 19 years of age, disability adults as well as at-risk veterans across the Flint, Beecher, Grand Blanc, Swartz Creek, and Mount-Morris Michigan communities.

<u>Vision-</u> The vision of our organization is to use new and creative ideas to give the members of our local community a platform to discover new ways of thinking and solve problems without resorting to drugs, Harm Reduction, violence, and possibly suicide.

We explore pathways for prevention and recovery from addiction for individuals and families, as well as an excellent vehicle for addressing the stigma associated with addiction and recovery from substance use disorders and the formal treatment of substance use disorders.

<u>Use of Funds</u> - This funding will help us further our mission to provide empowerment and literacy programs that educate the community on the effects of opioids, e-cigarettes, CBD, addiction prevention and recovery, harm reduction, and the overall impact of trauma on adolescents and families.

Our organizational strategy uses animated videos to help inform our K-12 audience, and education workshops for adults to help assist them with strategies for drug abuse prevention, recovery, and trauma-informed care. Through our efforts, the youth we engage learn how to be in touch with their emotions and to engage in expression suppression inhibiting their emotions to create a better life for them every day. We conduct ongoing drug abuse prevention & prevention amp; trauma-informed care education literacy workshops in collaboration with local community-based healthcare partners that teach about the safe use of medication; how to practice safe dosages; remembering the importance of safe medication usage; understanding the concepts of over-the-counter usage and abuse.

#### Proposal

This proposal is for medication and concepts of drug facts, as well addiction prevention and

recovery. Our creative activities will help build and sustain relationships across the community that will allow us to respond to the diverse needs of the overall community, with an intentional concentration on the youth population. With an added program component to engage senior adults, our organization will be able to empower the family. In one sentence, the DWLF Drug Abuse Prevention & Earney Trauma Informed Care education program provides unique solutions and partnerships to help support the delivery of critical public health, drug prevention, and recovery created by LBD Legacy Consulting LLC strategies, medical, and community-based interventions that will lead to positive health outcomes for the children and families of Flint, MI. We have been operating this type of work in the community since 2015.

DWLF services include (but are not limited to): prescription medication literacy workshops; training on the proper safe storage and usage of the medication, Over the counter- as well as informational sessions on the risks of developing addictions as well as other side effects of improper medication usage and the benefit of drug abuse prevention & trauma-informed care training. DWLF also offers programs that teach the concepts of drug abuse and the sharing of information and resources to those affected, addicted, and/or recovering.

We recognize that collaboration is essential to the continued success of services to the community. These collaborations help us reduce costs while also leveraging trained health professionals to assist in our workshops and training activities. Support from the community members, donors, and local government will remain very important for the success of the project. We have been collaborating with other organizations on other projects and we have engaged with them to support this grant proposal and beyond.



#### **Background/Summary of Proposed Action:**

Mott Park Neighborhood Association: Funding request and purpose: Requesting \$50,000 for Accessibility for Mott Park Project funded through Neighborhood Engagement Hub as the fiduciary; As one of the final pieces in the park's master plan to address blight, add improvements, and ensure maintenance of the park, the neighborhood would like to add a 10-foot-wide asphalt path that would enable access to the amenities in Mott Park, including our playground, bicycle garden, tennis court, hockey rink, and (still in progress) basketball court. In doing so, those areas would be less susceptible to blight and maintenance issues due to more regular use and "eyes on the area" by those using the path. Mott Park is built in a valley with steeply sloped hills. The neighborhood's second phase of this project expands the trail to follow the park's perimeter as an added loop. This phase is not included in this proposal but should be known. The neighborhood will contract with an asphalt company to install the trail. They will do all the work, including altering slopes, filling holes, putting down gravel foundations, pouring asphalt, leveling dirt, and planting grass. The neighborhood will contract with an asphalt company to install the trail. When complete, all of their neighbors will have access to the beautiful amenities in our park. The neighborhood is especially mindful of wheelchair-bound neighbors, but this will benefit their youngest neighbors, who may be pushed in strollers, and their elderly neighbors, who may not be comfortable walking down steep grassy hills.

<u>History</u>: Since 2009, Mott Park has been the focus of blight elimination efforts to restore the park to a safe and attractive place for residents to use for leisure and recreation.

#### **Background/Summary of Proposed Action:**

Asbury Community Development Corporation: Funding request and purpose: Requesting \$100,000 for Asbury Community Kitchen; Asbury's Community Kitchen launched on July 1, 2023, and during the first phase it featured an outdoor venue adorned with food-bearing plants, local art, and our mobile food trailer. At the completion of Phase Two, participants will enjoy indoor events featuring chefs teaching tasty and healthy meal preparation based on local ingredients. Residents sample food selections and take home ingredients to prepare meals for themselves and their families.

The Community Kitchen's secondary farmer's market is an expansion of Asbury CDC's programs that provide youth and young adults with job readiness skills and address food insecurity in the surrounding neighborhoods while also providing local farmers with additional days to sell their produce in Flint.

The activities will include paving 33,300 square feet of parking lot, installing farmers market stalls and picnic tables, and hiring a farmers market coordinator to onboard farmers and drive traffic weekly.

The secondary farmers market will provide an additional way to distribute and engage with local residents. Residents will be invited to grow with us by volunteering on our farm and as a reward for their volunteerism, they receive a credit that allows them to pick up produce at the secondary farmers market, therefore increasing food access and especially for those who experience food insecurity and were negatively impacted by COVID 19.

This proposal increases food access for Flint residents by allowing increased access to local agricultural products on days and hours that the Flint Farmer's Market is closed. Over 90 thousand visits are anticipated in the first three years of operation. Their plan leverages funding from the City of Flint CDBG (\$150,000) and the Healthy Food Finance Initiative (\$200,000) that allows them to purchase a site for the Asbury Community Kitchen. Over three years, this project will result in \$600,000 in local produce and other food items being sold or distributed.

#### History:

Asbury Farms (Flint, MI) works to strengthen its neighborhood by transforming blighted and underused land into community gardens and supporting local residents interested in growing fresh food or earning a living from food production.

The idea for Asbury Farms arose out of the strategic decision of the leaders at Asbury Community Development Corporation to be a center for health and wellness in their Flint neighborhood. The community around Asbury Farms has experienced unacceptable lead levels in its public drinking

water and faces substantial food insecurity and a high incidence of youth crime. It is one of the poorest neighborhoods in Michigan. Asbury Farms helps to alleviate these neighborhood stresses by transforming empty property into thriving community gardens; increasing access to fresh, healthy food; providing employment opportunities to neighborhood youth; and offering residents a pathway toward greater financial security through its farm incubator program.

#### **Background/Summary of Proposed Action:**

R.L. Jones Community Outreach Center: Funding request and purpose: Requesting \$100,000 for Access and Functional Needs Program; Since the Water Crisis, R.L. Jones Community Outreach Center has served as a Help Center/ Resource Center for seniors and families to receive water and food. R.L Jones Community Outreach Center assists residents in 1,364 households weekly through their Access and Functional Needs (AFN) delivery service. The AFN Program Delivery Services division provides critical resources to citizens at their place of residence. The need for water delivery for seniors over the age of 85 has increased since the COVID-19 pandemic. They are continuing to provide foods high in protein and foods high in various vitamin nutrition. They also partner with GCCARD and the Food Bank of Eastern Michigan to purchase the various supplies used for our food distribution services.

The items distributed through all divisions have expanded including an increase in requests for cleaning and personal care items. They are now providing detergent, disinfectant cleaning supplies Clorox, Lysol Wipes, Hand Sanitizer, etc. Families show an increased need for baby food, toothpaste, bath soap, deodorant, milk, diapers, adult diapers, shampoo, conditioner, mouthwash, snacks, etc. While many of the residents they service are seniors through our AFN Delivery, many of them care for grandchildren and other young family members which increases the need for essentials for small children and babies.

In their area, normally senior citizens and the disabled do not get very good access to public transportation allowing them to get to a store to pick up everyday household items. In addition, their area of the city has no regular grocery stores that are within walking distance for many residents. Therefore, there was a huge need to have items brought to them which is what led to the development of the Access and Functional Needs Program. The senior population is particularly vulnerable to rising costs. Too many seniors are having to choose between purchasing prescriptions versus food, so they can step in to fill that gap and provide them with nutritious foods ensuring they no longer have to pick food or medication. There are definite health inequities that exist for these particularly vulnerable populations regarding food access. R.L. Jones Community Outreach Center works to address these inequities through the services we provide in the community.

#### History:

For over 50 years, Greater Holy Temple Church Of God In Christ has been a landmark in North Flint and is the home of the R.L. Jones Community Outreach Center (COC) which was established in 2016. The Center is dedicated to the promotion and maintenance of optimal health and wellness for residents affected by the Economy, Water and COVID-19 Crisis and beyond.

They have four priority service areas: The Catherine's Closet of Hope, Access and Functional Needs Home Deliveries (AFN), Youth in Action and Adult Job Training Program (Job Readiness Program) and a Resource Center that includes Health and Wellness, Social Services and Food Distribution and Nutrition.

They are dedicated to the promotion and maintenance of optimal health and wellness for patients dealing with short-term illnesses, rehabilitation and recovery during the food insecurity crisis in Flint and the surrounding areas. The COC-Nutrition Center is located on the Northside of Flint, Michigan; and is a convenient and trusted resource hub for individuals seeking a holistic approach to address the effects of food insecurity and lead poisoning on their health and well-being.

The Resource Help Center provides weekly food distribution on Thursdays. Through our HELP Center we assist an average of 300 vehicles which equates to approximately 900 residents per week.

Families who receive SNAP benefits recently saw reductions in the COVID-19 emergency food assistance payments which they had been receiving. These families have been turning to the HELP Center to get food which was previously covered by their increased SNAP benefits. In addition, many of the families we service are not eligible for these benefits. They come from working class homes whose incomes are higher than the allowable amounts. As costs for goods have increased there has been a dramatic rise in health disparities regarding families being eligible to purchase healthy foods, so the HELP Center has helped fill this gap.

#### **Background/Summary of Proposed Action:**

Organization - Insight Med-Psych Healthcare Services and Hospital

<u>Use of Funds</u> - The Medical Psychiatric Specialty Hospital and Healthcare plan currently has a funding gap to begin operations once construction for phase 1 with 24 beds is completed in 2024. Approximately 70 new positions will need to be filled including nurses and medical assistants.

In August of 2021, the State of Michigan granted Insight the certificate of need (CON) to proceed with a 70-bed inpatient med-psych unit in Flint, MI. The facility is a dual-diagnosis facility, being able to provide care to patients who need in-patient medical diagnoses as well as psychiatric diagnoses. Patients will be admitted to the facility from referring public safety agencies, area hospitals, and community clinics. The hours of operation will be 24/7 allowing for patients to receive care at any time. Patients will be discharged once all criteria have been met including outpatient treatment plan, family/return to home plan, and a social worker connection.

The Insight Medical Psychiatric Specialty Hospital and Healthcare Services is a partnership between Insight Management (IMACS) and the nonprofit 501(c)(3) Insight Research Institute (IRI). The construction will be done in a multi-stage approach, and the first 24 beds are expected to be completed by the fall 2024.

History -The new specialty hospital is the latest addition to the Insight Flint Medical Campus located at 4800 S. Saginaw St. in Flint at the former General Motors office. A \$2.5 million grant from the Michigan Department of Health and Human Services is funding the construction of the space for the first 16 beds. The former GM building was part of the Fisher Body No. 1 plant until it was retrofitted into an engineering and design center as part of the Great Lakes Technology Center before becoming Insight Flint's Medical Campus in 2009.

Whereas, On March 11, 2021, the President of the United States of America signed into law the "American Rescue Plan Act of 2021", also known as House Resolution 1319, an Act approved by the Congress of the United States, and which authorized the Treasury of the United States to disburse certain funds to local governments, including the City of Flint, which could be used for specific and defined purposes; and

Whereas, In accordance with the American Rescue Plan Act of 2021, the City of Flint wishes to exercise its right to extend and disseminate assistance to impacted households tied to specific criteria, as authorized by the Act, to assist citizens who may have been impacted financially by the ongoing COVID-19 Pandemic; and

Whereas, The administration recommends funding to Improve Parks and Community Centers in the amount of \$1,368,158.23 from the category of Neighborhood Improvement # HB06 as part of City Council Resolution 220464.1, Proposed ARPA Allocation Plan, on October 24, 2022.

According to the City of Flint ARPA plan, the desired outcomes for this category are:

- Decreased blighted structures.
- Decrease migration out of Flint.
- Increased property values.
- More diverse housing options.

#### A. BRENNAN PARK

- · Safely Remove four red light post bases at Brennan Park Per addendum
- · Disposal of concrete base is included
- Backfill of holes is included in this proposal
- · Electrical permit is included

#### B. BROOME PARK

- Remove the outdated scoreboard and light posts surrounding the old skating rink at Broome
   Park
- · Removal of concrete bases and electrical underground
- · Backfill all holes created by removal of concrete bases
- · Electrical permit is included

#### C DEWEY PARK

- Furnish and install electrical connection for Mini pitch at Dewey Park
- o Please note, there is not an electrical connection currently close to the mini pitch.
- All Consumers Energy Fees are excluded from this proposal. As we do not know what their costs will be. (To be discussed if we are awarded the project)
- · Electrical permit is included

#### D. MCKINLEY PARK

- Furnish and install electrical connection for future mini pitch. We will have power nearby in a
  lockable panelboard to ensure it does not get broken into while waiting on the mini pitch to be
  installed.
- Remove existing parking lot lights and install (2) new high output solar lights with battery backup in the parking lot.
- Electrical permit is included

#### E. KEARSLEY PARK

- Furnish and install all labor and materials needed to troubleshoot and repair all lighting inside and outside of the pavilion
- o We did not include troubleshooting for lights that are not exposed to general public. {Only the lights I could visually see without getting inside the pavilion)
  - Furnish and install labor and materials needed to repair exterior mounted receptacles
  - Electrical permit is included

#### F. OPHELIA BONNER PARK

- Remove the baseball stadium lights and the old electrical boxes in the field at Ophelia Bonner
- Park
- Removal of all wooden poles and lights are included
- Electrical permit is included
- Backfill all holes created by removal of wooden holes

#### G. SARVIS PARK

- Install bollards to fill the perimeter between the fencing and existing bollards to prohibit vehicle
- access and illegal dumping.
- Sidewalk maintenance along the perimeter of the park. Replace broken slabs, clear overgrowth, and
- Clean up fair-condition slabs.
- Restore the Nature Nook by removing dead trees and overgrowth. Install seating, plants landscaping.

The combined cost for these seven projects is estimated to be \$1,368,158.23 which is the amount allocated for parks and recreation in the ARPA fund.
