This Addendum has also been issued to address the following Q&A:

Request for modification to Specifications and/or Scope of Work:

- 1. The City of Flint will adhere to the advertised specification criteria.
- **2.** The substitution request for a PVC single-ply membrane does not meet the specification standards in the following categories:
 - a. Warranty (Length and/or Coverage Type)
 - b. Acceptable Manufacturers (Not Listed)
 - c. Roofing Material ASTM D5147
 - d. Roofing Material ASTM D6163
 - e. Roofing Material ASTM D312
 - f. Roofing Material ASTM D6162
 - g. Roofing Material (Thickness, Tear Strength, Thickness over Scrim)

General Questions:

- 1. Can we email bids or do they have to be hand delivered?
 - 1. Both hard, sealed copies *and* an electronic copy are required per the RFP outlines.
- **2.** Area "D" is the only area that had a full tapered system on it, so is this the only area we are to install a full tapered system? Need to know what insulation is required for each area.
 - 1. Areas with structural slope will require an Average R-30, non-tapered polyisocyanurate system.
 - 2. Areas without structural slope will require an Average R-30, ¼" tapered polyisocyanurate insulation system.
- **3.** Area "O" doesn't have enough height to install an R-30, let alone any tapered. The existing roof system was only about 2" total thickness. Please advise on what will be required here.
 - 1. Several Roof Sections have design-limiting characteristics. The intent is to match the existing insulation thickness for Roof Section "O".

- **4.** Area "O" we need an expansion joint detail to meet warranty requirements. Right now it is maybe an 1" above the existing roof. Also there was talk about flashing the EJ on the dome side. Need to with what materials? Liquid flashing?
 - 1. The intent is to replace the existing expansion joint with a matching design.
- 5. Can the cover board be installed with asphalt seeing the rest of the insulation is being installed in asphalt?
 - 1. Yes, this is acceptable.
- **6.** On Area "A" is the lightning protection staying, being removed, being reinstalled and recertified, and by who?
 - 1. Lightning protection is to be removed, reinstalled and recertified by the roofing contractor.
- 7. There is talk in the spec about the manufacturer not being responsible if asbestos is present. Has any report been done by a certified asbestos person or if not are we to just bid the job as no asbestos on the project?
 - 1. The City of Flint will provide asbestos testing information if available.
- 8. Specs talk about ANSI/SPRI ES-1 metal. There is small amount of gravel stop and gutter on this project, most of the metal is counter flashing on this project. Will shop fabricated metal be acceptable and will the new metal just be galvanized prefinished? No new copper anywhere?
 - 1. Shop fabricated, 24 ga. Kynar coated steel will be acceptable for these requirements.
- **9.** On Area "A" the overflow scuppers may get partially/if not all buried due to the increase of insulation thickness to R-30 and then saddles between the drains.
 - 1. Roof Section "A" is to receive polyisocyanurate matching the existing insulation thickness throughout.
- **10.** Scope talks about replacing a roof hatch. I don't remember seeing one on any of these sections. Is there actually one to replace and if so on what area?
 - 1. Please disregard Items "N" and "O" on the Summary of Scope of Work Page.
