Settlement/2024 National Settlement of In Re: National Prescription Opiate Litigation (MDL No. 2804)/Kroger Co.

Resolution resolving that the appropriate City officials are authorized to do all things necessary to approve, effectuate and/or enter into the 2024 settlement with Kroger Co., with respect to the National Prescription Opiate Litigation for the City of Flint. [NOTE: On or about February 18, 2019, the City joined the ranks of communities nationwide who filed lawsuits against manufacturers and distributors of prescription opioids, to recover resources spent responding to and addressing opioid addiction and abuse in their communities. These lawsuits, collectively, are commonly referred to as "In Re: National Prescription Opiate Litigation (MDL No. 2804). City Administration and the Law Department recommend approving the City of Flint's participation in the 2024 settlement with Kroger Co. to ensure that the City receives its share of the settlement proceeds. [NOTE: An Executive Session was held in this matter on July 17, 2024.]
