Any person that persists in disrupting this meeting will be in violation of Flint City Code Section 31-10, Disorderly Conduct, Assault and Battery, and Disorderly Persons, and will be subject to arrest for a misdemeanor. PUBLIC COMMENT

Members of the public who wish to address the City Council or its committees must register before the meeting begins. A box will be placed at the entrance to the Council Chambers for collection of registrations. No additional speakers or slips will be accepted after the meeting begins.

Members of the public shall have no more than three (3) minutes per speaker during public comment, with only one speaking opportunity per speaker.

COUNCIL RESPONSE

Councilmembers may respond once to all public speakers only after all public speakers have spoken. An individual Councilmember's response shall be limited to two (2) minutes.

CONSENT AGENDA

Per the amended Rules Governing Meetings of the Flint City Council (as adopted by the City Council on Monday, April 22, 2024), the Chair may request the adoption of a "Consent Agenda". After a motion to adopt a Consent Agenda is made and seconded, the Chair shall ask for separations. Any agenda item on a Consent Agenda shall be separated at the request of any Councilmember. After any separations, there is no debate on approving the Consent Agenda — it shall be voted on or adopted without objection.


The City of Flint and the Flint Police Officers Association (FPOA) have negotiated a successor Collective Bargaining Agreement (CBA).



**RESOLUTION APPROVING REALLOCATION OF \$1,000,000
IN ARPA FUNDS TO WATER RATE STABILIZATION FUND**

AO617

BY THE CITY ADMINISTRATOR:

WHEREAS, the Great Lakes Water Authority (GLWA) voted on February 25, 2026 to increase water rates to its 88 municipal customers including the City of Flint for Fiscal Year 2027; and

WHEREAS, GLWA's Board of Directors approved an increase of approximately 5.8 percent; and

WHEREAS, GLWA also approved a 5.9 percent water rate increase for FY 26; and

WHEREAS, although Flint residents have not received a water rate increase since 2015 because the City has absorbed these rate hikes; and

WHEREAS, otherwise such significant rate increases would present a financial hardship for this community; and

WHEREAS, the City of Flint received federal funds pursuant to the American Rescue Plan Act of 2021 (ARPA); and


WHEREAS, the City of Flint obligated approximately \$40 million as "revenue replacement" on December 20, 2023; and

WHEREAS, in order for the City of Flint to avoid passing GLWA's approved water rate increase to its residents, City Administration recommends reallocating \$1,000,000 in ARPA funds, originally intended for revenue replacement, to the Water Rate stabilization fund to defray the rate increase; and

WHEREAS, reallocated funds will be moved from Account No. 101-000.000-995.591 as follows:

Account	Description	Amount
591-000.000-699.101	Water Rate Stabilization Fund	\$1,000,000

THEREFORE BE IT RESOLVED that the appropriate City officials are authorized to do all things necessary to transfer \$1,000,000 in funding from source Account No. 101-000.000-995.591 to the Water Rate Stabilization Fund Account No. 591-000.000-699.101 to cover the Great Lakes Water Authority's FY27 water rate increase.
