**ORDER No. 9**

**MAYOR DAYNE WALLING'S RESPONSIBILITIES AND  
PARTIAL RESTORATION OF COMPENSATION**

BY THE POWER AND AUTHORITY VESTED IN THE EMERGENCY MANAGER ("EMERGENCY MANAGER) FOR THE CITY OF FLINT, MICHIGAN ("CITY") PURSUANT TO MICHIGAN'S PUBLIC ACT 4 OF 2011, THE LOCAL GOVERNMENT AND SCHOOL DISTRICT FISCAL ACCOUNTABILITY ACT, ("PA 4"); MICHAEL BROWN, THE EMERGENCY MANAGER, ISSUES THE FOLLOWING ORDER:

On March 16, 2011, the Local Government and School District Fiscal Accountability Act, Public Act 4 of 2011, ("Public Act 4") was enacted to safeguard and assure the fiscal accountability of units of local government; to preserve the capacity of units of local government to provide or cause to be provided necessary services essential to the public health, safety and welfare of citizens; and

Governor Rick Snyder appointed Michael Brown as the Emergency Manager for the City of Flint on November 28, 2011, and his contract was approved by the State Treasurer on November 29, 2011; and

Pursuant to Public Act 4, the Emergency Manager has broad powers in receivership to rectify the financial emergency and to assure the fiscal accountability of the City of Flint and its capacity to provide or cause to be provided necessary services essential to the public health, safety and welfare; and

Pursuant to Public Act 4, the Emergency Manager acts in place of local officials, specifically the Mayor and City Council, unless the Emergency Manager delegates specific authority; and

Pursuant to Public Act 4, the Emergency Manager may restore, in whole or in part, any of the salary, wages, other compensation, or benefits of the chief administrative officer during the pendency of the receivership, for such time and on such terms as the Emergency Manager considers appropriate, to the extent the Emergency Manager finds that the restoration of salary, wages, compensation, or benefits is consistent with the financial and operating plan.

Based on the above, the salary of Mayor Dayne Walling is hereby restored to sixty (60%) percent of his base salary, along with restoration of all benefits. Mayor Walling shall serve as a full time employee of the City of Flint with responsibilities focused on economic development, master planning, intergovernmental affairs, and community engagement, including, but not limited to:

#### Economic Development

- Focus on job creation, business development, entrepreneur support
- Facilitate economic development prospects and projects with DCED staff
- Develop City of Flint policies and procedures to create positive business climate
- Chairman, City of Flint Economic Development Corporation
- Chairman, City of Flint Downtown Development Authority
- Board Member, Flint Genesee County Visitors & Convention Bureau
- Board Member, Flint Area Enterprise Community
- Operating Board Member, Genesee Regional Chamber of Commerce
- Steering Committee Member, E3 Innovation Network
- Executive Committee Member, Michigan Economic Development Corporation
- Weekly “Jobs” Meeting with GRCC and partners
- Liaison to local business associations and entrepreneur support networks

#### Comprehensive Master Planning

- Focus on developing a City of Flint Comprehensive Master Plan
- Identify and promote research-based best-practices
- Ensure robust community engagement and citizen participation
- Assist Chief Planning Officer and Planners Roundtable
- Support Community Steering Committee and Stakeholders’ Network
- Integrate Sustainability principles in accordance with US Dept of HUD funding including brownfield redevelopment and environmental quality improvement

#### Intergovernmental Affairs & Policy

- Focus on strengthening relationships with State and Federal government entities
- Identify State and Federal grant, partnership, and resource development opportunities
- Trustee, Karegnondi Water Authority
- Member, Mayor’s Automotive Coalition
