

Resolution resolving that the Flint City Council approves the reappointment of **Jason Caya** (119 North Grand Traverse Street, Flint MI 48503 - Ward 5) to serve a five-year term on the Hurley Board of Hospital Managers, commencing May 15, 2019, and expiring April 30, 2024, as requested by Mayor Karen W. Weaver.

Resolution resolving that the Flint City Council approves the reappointment of **Jessie L. Collins** (622 E. Ridgeway Avenue, Flint, MI 48505) to an additional five-year term on the Hurley Board of Hospital Managers, with such term to commence September 14, 2020, and expire April 30, 2025. [By way of background, Mr. Collins' term on the (Hurley) Board of Hospital Managers expired April 30, 2020.]

An amended resolution resolving that the Flint City Council approves the reappointment of **Charlotte P. Resolution resolving that the Flint City Council approves the appointment of **Corinne Edwards** (3410 Westwood Parkway, Flint, MI 48503) to complete the term of Dr. Ronald Stewart on the Hurley Board of Hospital Managers, with such term commencing on October 27, 2020, and expiring on April 30, 2025. [NOTE: By way of background, Dr. Stewart's term expired in May 2019, although he continued to serve.]

Resolution approving the reappointment of **Christopher Flores** (1502 Brookwood Drive, Flint, MI, 48503) to the Hurley Board of Hospital Managers for an additional five-year term, commencing immediately, and expiring April 30, 2026, as requested by Mayor Sheldon Neeley. [NOTE: By way of background, Mr. Flores' term on the Hurley Board of Hospital Managers expired April 30, 2020, although he continued to serve.]

Resolution approving the reappointment of **Marilyn Fuller** (2620 Pewanaga Place, Flint, Michigan, 48507) to the [Hurley] Board of Hospital Managers for a five-year term commencing May 1, 2016, and expiring April 30, 2021, as requested by Mayor Karen W. Weaver.

Resolution resolving that the Flint City Council approves the reappointment of **Frances Gilcreast** (4322 East Mt. Morris Road, Mt. Morris, MI 48458) to serve an additional five-year term on the (Hurley) Board of Hospital Managers, commencing May 1, 2018, and expiring April 30, 2023.

Herbert Miller II** (930 East Myrtle Avenue, Flint, MI 48505) to serve the remainder of a five-year term on the Hurley Board of Hospital Managers, commencing immediately and expiring April 30, 2022. [By way of background, Rev. Miller is replacing Ada Washington, whose term on the Board of Hospital Managers ended on April 30, 2017, although she continued to serve.] [NOTE: Resolution amended to add additional background information.]

Resolution resolving that the Flint City Council approves the reappointment of **Brian Nolan, M.D.** (4495 Warwick Circle Drive, Grand Blanc, MI 48439) to an additional five-year term on the (Hurley) Board of Hospital Managers, with such term to commence September 14, 2020, and expire April 30, 2025. [By way of background, Mr. Nolan's term expired April 30, 2020.]

Resolution resolving that the Flint City Council approves the reappointment of **Harriet Scott** (1401 Woodslea Drive, Flint, MI, 48507) to serve a five-year term on the (Hurley) Board of Hospital Managers, with such term to commence May 1, 2018, and expire April 30, 2023.

Resolution resolving that the Flint City Council approves the reappointment of **Philip W. Shaltz** (14144 Moffet Drive, Fenton, MI 48430) to an additional five-year term on the (Hurley) Board of Hospital Managers, with such term to commence May 1, 2018, and expire April 30, 2023.

Resolution resolving that the Flint City Council approves the appointment of **Marsha L. Wesley** (1655 Neome Drive, Flint, Michigan, 48503) to the City of Flint (Hurley) Hospital Board of Managers for a five-year term, commencing September 14, 2020, and expiring May 31, 2025.
