I. MEETING CALL TO ORDER:

There being a quorum, the Economic Development Corporation board meeting was called to order by Councilman Kerry Nelson at 8:47 a.m.

II. PUBLIC COMMENTS:

Mr. Hall, owner of Premier Powder Coating addressed the board. He said he met with the OBC Committee to discuss leasing another unit. He inquired about unit 12, which is currently being used by a non-tenant to store water. Mr. Hall said he was told by Mr. Evans the water would be removed by Friday May 6, 2016.

Ms. Dunlap said that Mr. Evans had allowed a pastor to store water in unit 12.

Mr. Evans assured the board that the water would be removed by Friday.

Mr. Hall stated that he now has light in the rear parking lot near his unit but it is wired to his circuit breaker and he is paying for it. He asked that it be addressed.

III. Approval of Previous Meeting's Minutes

It was moved by Ms. Naphier and supported by Mr. Munroe to approve the March 1, 2016 minutes. Motion passed unanimously.

IV. Reaffirming Resolution

Councilman Nelson stated that the reaffirming resolution reaffirms the actions taken by the EDC President to carry out the OBC day to day operations between meetings.

Mr. Hammond stated that Mr. Freeman was interim Secretary for the EDC before he resigned, so asked that a new interim secretary be elected.

There was a motion to elect Mr. Munroe for interim Secretary of the EDC Board of Directors.

It was moved by Mr. Hammond and supported by Ms. Naphier to elect Mr. Munroe as Interim Secretary of the EDC Board of Directors. Motion passed unanimously.

It was moved by Mr. Hammond and supported by Ms. Naphier to approve the reaffirming resolution. Motion passed unanimously.

V. Financial Reports

EDC Financial Report for month ended March 31, 2016

Mr. Goble reported the Economic Development corporation financial reports for the month ended March 31, 2016.

Mr. Hammond asked what the CDBG Bond was being used for, and why was it reported on EDC financial report each month.

Ms. Dunlap clarified that it was not a CDBG bond and that in 2010, the EDC issued a bond for the construction of the Department of Human Services Building. She said the funds that are reported on the EDC financial report, are not funds that are available for the EDC's use. The funds show up as a receipt of funds but are immediately used for the management of the building.

Mr. Hammond suggested that the board get a regular report on projects associated with the brownfield plans approved by the BRA

Ms. Dunlap said the only ongoing Brownfield Development Plan project that the EDC has is the IRS building. She said the EDC is reimbursing the Developer for eligible expenses for the construction on the IRS building located at Louisa and N. Saginaw St.

It was moved by Mr. Hammond and supported by Mr. Munroe to approve the EDC March 31, 2016 financial reports. Motion passed unanimously.

Ms. Dunlap mentioned that another Brownfield Plan was presented to her. The location of that Brownfield project is at 1409 E. Pierson Rd. The owners want to renovate the building and produce pellets from wooden pallets.

Ms. Dunlap explained OBC Fund 583 proposed budgets for fiscal year 2016-17 and 2017-18.

Questions were raised regarding OBC Fund 583 proposed budget for year 2016-17 and 2017-18.

It was moved by Mr. Hammond and supported by Mr. Munroe to adopt the OBC Fund 583 proposed budget for fiscal year 2016-17 and 2017-18. Motion passed unanimously.

Ms. Dunlap explained Fund 244 EDC RLF, proposed budgets for fiscal year 2016-17 and 2017-18.

Mr. Hammond asked how the \$30,000 that we receive from the General Fund relates to the EDC Deficit Elimination Plan.

Ms. Dunlap explained that the \$30,000 the EDC receives from General Fund keeps the EDC operating since it doesn't generate any revenue on its own. The only money it has coming in is generated from interest income off the loan program, which can only be used for the administration of the loan program.

It was moved by Mr. Hammond and supported by Mr. Munroe to adopt Fund 244 EDC RLF proposed budget for fiscal year 2016-17 and 2017-18. Motion passed unanimously.

Ms. Dunlap explained Fund 241 State RLF proposed budget for fiscal year 2016-17 and 2017-18.

It was moved by Mr. Hammond and supported by Mr. Munroe to adopt Fund 241 State RLF proposed budget for fiscal year 2016-17 and 2017-18. Motion passed unanimously.

Ms. Dunlap explained OBC 5 Year Deficit Elimination Plan proposed budgets. She said to eliminate the deficit, OBC anticipates implementing the following strategies:

- Opening of a satellite office of the SBC, (office located in the OBC)
- Market to small businesses using the services along with OBC brochure
- Lease-up to two additional industrial units
- Realization of 3% increase in the American Tower rent
- Use of more CDBG funds for facility improvements
- Work with Flint Genesee Chamber to get more businesses loans out

Ms. Naphier suggested the EDC invite Ms. Dawn Jones from ABC12 WJRT to help get the word out to the community.

It was moved by Mr. Hammond and supported by Mr. Munroe to adopt OBC 5 Years Deficit Elimination Plan proposed budget. Motion passed unanimously

VI. Oak Business Center Committee Report.

Mr. Evans shared that OBC gets calls and walk-ins from businesses inquiring about leasing space. The issue is that the units and office space are not ready for leasing.

Ms. Dunlap said she would inquire with the Planning & Development Department to see if she could use their P-Card to install the carpet that OBC needs to ready the three small units in the front.

Ms. Dunlap reported, that W.T. Stevens is \$3,870.00 behind in the rent, an eviction notice will be sent to them.

It was moved by Mr. Hammond and supported by Ms. Naphier to accept the OBC report. Motion passed unanimously.

VII. Loan Review Committee Report

Ms. Shavers reported that payments were made on all of the EDC loans with the exception of Banks & Banks and Pasadena Fresh Meat & Fish Market.

Ms. Shavers stated that she had received a payment from Mr. Farah of Pasadena meats...

Ms. Dunlap noted at the Loan Review Committee meeting Mr. Farah sent a letter to the board requesting that his monthly payments be reduced by \$200.00, for a new monthly payment of \$185.97. The Committee agreed to reduce the monthly amount for one year and re-evaluate the situation at that time.

Mr. Erwin Meiers requested to pay \$5,000 to satisfy his loan amount. The Loan Committee saw that Mr. Meiers had paid more than the amount borrowed through the combination of principal and interest payments. The Loan Committee wants Mr. Meiers to submit his request in writing. Ms. Dunlap said that when Ms. Shavers checked with the accountant at Abraham & Gaffney for Mr. Meiers' loan balance, it was less than the \$5,000. Mr. Meiers' decided to continue to pay on the loan until paid off.




