
### **Legal Department Mission**

The Legal Department staff is here to advise, assist, defend, and advocate for City employees, elected officials, and their departments when any lawsuit is filed against them in their official capacity. As the attorneys for the City, all communications made directly with the City Attorneys are confidential and privileged from disclosure to outside organizations, even as to copies of communications sought under F.O.I.A.

## **City Ordinance and Resolution Preparation and Review**



The Legal Department is available to assist with the review and preparation of resolutions and ordinances consistent with the law.

### **Legal Department Services**

### **City Attorney's Office - Criminal Division**



The City Attorney is the City's prosecutor and therefore initiates, on behalf of the People, cases arising from the provisions of the Charter or City ordinances. Attorney Kelly Kiertzner is assigned to the day-to-day operation of the City Attorney's Office Criminal Division and prosecutes all actions for the recovery of fines, penalties and restitution.

### **Damage Claims**



When there is a claim of damage as a result of an agent of the City, the Legal Department reviews, investigates and evaluates claims submitted for compensation. ### **Legal Opinions**



Whether it is on-the-spot, verbal feedback regarding a particular course of action, set of facts, or a detailed, written legal opinion as to the ramifications surrounding a change in the law as to specific City practices, the Legal Department provides an array of legal opinions on any legal topic affecting City business to Department heads, employees, City Administration, the City Clerk, and to the City Council.

### **Mediation Services**



At times, interdepartmental disputes arise. Conflicts may take the form of a formal complaint, or even litigation in which a court, tribunal or other body makes a final binding decision. As an alternative to litigation, mediation is a voluntary, self-determining process that parties may participate in to have their grievances heard, and resolve their claims in a constructive and lasting manner.

### **Training/Seminars**



The Legal Department may assist in updates to the law to keep departments, employees and City officials in compliance with local, state and federal laws. The Legal Department offers trainings, including on subjects such as compliance with F.O.I.A, the Open Meetings Act, Roberts Rules of Order, and the preservation of documents for litigation, among other topics upon request. These trainings are available throughout the year.

### Freedom of Information Act (F.O.I.A.)



Under the Michigan Freedom of Information Act, with a written request for a public record, a person has a right to inspect, copy, or receive copies of the requested public record of the public body. As a result, the Legal Department reviews and processes requests for City documents under the F.O.I.A.
