The \$160,339.00 will come from the following General Fund accounts: 101-325.100-702.000 = \$88,977.55; 101-325.100-709.000 = \$36,979.37; 101-325.100-719.100 = \$5,451.53; 101-325.100-719.200 = \$28,843.47; and 101-325.100-719.310 = \$87.08.] [NOTE: The adjustment is due to the city's 911 services being extended from June 30, 2015, to August 31, 2015.]
