ORDER No. 1

BI-MONTHLY CITY COUNCIL AND COMMITTEE MEETINGS

BY THE POWER AND AUTHORITY VESTED IN THE EMERGENCY MANAGER ("EMERGENCY MANAGER) FOR THE CITY OF FLINT, MICHIGAN ("CITY") PURSUANT TO MICHIGAN'S PUBLIC ACT 436 OF 2012, LOCAL FINANCIAL STABILITY AND CHOICE ACT, ("PA 436"); GERALD AMBROSE, THE EMERGENCY MANAGER, ISSUES THE FOLLOWING ORDER:

Pursuant to Public Act 436, the Emergency Manager has broad powers in receivership to rectify the financial emergency and to assure the fiscal accountability of the City of Flint and its capacity to provide or cause to be provided necessary services essential to the public health, safety and welfare; and

Pursuant to Public Act 436, the Emergency Manager acts in place of local officials, specifically the Mayor and City Council, unless the Emergency Manager delegates specific authority; and

Pursuant to the City Council Organization Chart attached hereto and made a part hereof, the Flint City Council shall meet the 2nd and 4th Monday of every month at 6:00 pm and the Committee of the Whole shall meet the 2nd and 4th Monday of every month at 4:30 pm preceding the City Council meeting; and

Pursuant to the City Council Organization Chart attached hereto and made a part hereof, the Finance and Public Safety Committees shall meet the 1st Wednesday of every month at 4:30pm and 6:00pm respectively; and, the Public Works and Planning and Development Committees shall meet the 3rd Wednesday of every month at 4:30 pm and 6:00 pm respectively; and

Pursuant to the City Council Organizational Chart attached hereto and made a part hereof, the Finance, Public Safety, Public Works and Planning and Development Committees shall consist of three members appointed by the President of the City Council; and


The Legislative Committee is dissolved. The City Administration shall direct legislation to the appropriate committee based on subject matter.

Pursuant to Section 3-103 of the Flint City Charter, the Flint City Council shall adhere to its adopted rules of conduct; and

Pursuant to Section 3-201 of the Flint City Charter, the City Clerk shall post meeting dates and times, and all meetings shall be open to the public.

This Order is effective February 3, 2015.

This Order may be amended, modified, repealed or terminated by any subsequent Order issued by the Emergency Manager.
